

## **Pottawatomie County Free Fair 2021 Food Truck/Vendor Application**

**Location:** Shawnee Expo Center, 1700 W. Independence St Shawnee, OK 74804

**Date/Time:** September 8th-12th.

**About:** Come join us during the 82nd Pottawatomie County Free Fair. This is a family friendly event for people of all ages.

**Attendance:** Last year's fair brought over 800 people. We are anticipating over 1,000 people this year because of new events.

**Vendor Fees:** \$150. Application and fee must be received by no later than Friday, August 20th, 2021. All fees are nonrefundable after August 20th. **Make checks payable to:** Pottawatomie County Free Fair

**Food Truck/Vendor Application Acceptance Policy:** Confirmation for the Pottawatomie County Free Fair is based on the date and time of application submissions AND payment. Additionally, for food trucks, we will take your menu into account when we receive your completed application as our goal is to bring local food vendors/food trucks to the forefront to provide a unique experience for attendees by ensuring variety. While we are unable to guarantee there will not be competing vendors, we will take this into consideration as we receive vendor applications. The Pottawatomie County Free Fair reserves the right to turn down applications (and return fees) based on the number of applications received and overall variety of applications. **Make checks payable to:** Pottawatomie County Free Fair

**Proceeds:** Food trucks and vendors keep 100% of their proceeds for sales on the days of the event. However, food trucks/vendors are not allowed to sell ANY alcoholic beverages at this event. Every vendor will be required to post and submit a copy of the Oklahoma Tax Permit. All product sales at the Pottawatomie County Free Fair are subject to Oklahoma State and Shawnee City sales tax.

**Set-up, Hours, Teardown:** Food Trucks/Vendors may begin to arrive as early as 9 a.m. on Thursday, September 9th. All setup must be completed by no later than 4:00 p.m. The grand opening of the fair begins at 5:00 p.m. The fair closes at 8:00 p.m. Thursday night. Friday hours are 9:00 a.m. - 8:00 p.m. Saturday hours are 9:00 a.m. - 8:00 p.m. There will be NO teardown prior to 8:00 p.m. Saturday night.

**On-site Resources:** All food trucks and vendors must be able to operate independently of any provided resources at the Pottawatomie County Free Fair including water, electrical, refrigeration and any materials. Vendors are responsible for all set-up and clean-up of their booth space.

**Operating License Insurance:** Food trucks must provide the Pottawatomie County Free Fair with a copy of their **Operating License** no later than 1 week prior to the event.

**Temporary Food Service License:** Food trucks must also provide the City of Shawnee Health Department with all necessary required paperwork per City of Shawnee guidelines at least 1 week prior to the event.

Based upon the projected number of attendees, Food Trucks will likely be limited to no more than six (6) and applications will be reviewed on a first-come, first-served basis.

**Additional Food Truck/Vendor Information and Guidelines:** Food Trucks and Vendors will be provided spaces based upon their order of arrival. Food trucks and Vendors must plan on being there for the entirety of the fair. Sept 7th-9th. Please limit the total number of items to no more than six (6) so lines for attendees are quick and manageable. The event will be held rain or shine. Food safety is a primary concern. The Shawnee Health inspector will be doing an inspection prior to the event beginning. If you have any questions as to what needs to be done so you can operate, please call. Post all prices for items at your food truck. Please keep your area clean and do not throw trash on the ground.
