<u>Attendance:</u> Last year's fair brought over 800 people. We are anticipating over 1,000 people this year because of new events.

<u>Vendor Fees:</u> **No Charge.** Application must be received by no later than Friday, August 22, 2025.

Food Truck/Vendor Application Acceptance Policy: Confirmation for the Pottawatomie County Free Fair is based on the date and time of application submission. Additionally, for food trucks, we will take your menu into account when we receive your completed application as our goal is to bring local food vendors/food trucks to the forefront to provide a unique experience for attendees by ensuring variety. While we are unable to guarantee there will not be competing vendors, we will take this into consideration as we receive vendor applications. The Pottawatomie County Free Fair reserves the right to turn down applications based on the number of applications received and overall variety of applications.

<u>Proceeds:</u> Food trucks and vendors keep 100% of their proceeds for sales on the days of the event. However, food trucks/vendors are not allowed to sell ANY alcoholic beverages at this event. Every vendor will be required to post and submit a copy of their Oklahoma Tax Permit. All product sales at the Pottawatomie County Free Fair are subject to Oklahoma State and Shawnee City sales tax.

<u>Set-up, Hours, Teardown:</u> Food Trucks/Vendors may begin to arrive as early as 9 a.m. on Thursday, September 4th. All setup must be completed by no later than 4:00 p.m. The grand opening of the fair begins at 5:00 p.m. The fair closes at 8:00 p.m. Thursday night. Friday hours are 9:00 a.m. - 8:00 p.m. Saturday hours are 9:00 a.m. - 8:00 p.m. There will be NO teardown prior to 8:00 p.m. Saturday night.

<u>On-site Resources:</u> All food trucks and vendors must be able to operate independently of any provided resources at the Pottawatomie County Free Fair including water, electrical, refrigeration and any materials. Vendors are responsible for all set-up and clean-up of their booth space.

Based upon the projected number of attendees, Food Trucks will likely be limited to no more than six (6) and applications will be reviewed on a first-come, first-served basis.
